

Do Not Call Register

Application to check or remove up to 20 numbers

What is the Do Not Call Register?

The Do Not Call Register is a secure database where you can list your Australian numbers to opt out of receiving most unsolicited telemarketing calls and marketing faxes. Registration is free and you only need to do it once.

What numbers can be checked or removed with the Do Not Call Register?

If you are the account holder/nominee/authorised officer of a number, you can:

- > check the registration status of that number
- > remove the number—number(s) that are registered with the Do Not Call Register may be removed at any time.

If you wish to check or remove more than 20 numbers go to www.donotcall.gov.au.

How to use this form to check or remove up to 20 numbers

1. Complete all the sections below (A to E) and provide signatures where required.
2. Attach/provide a copy of the front page of a bill or other supporting evidence to verify the account holder/nominee/authorised officer for each number.
